

VISA APPLICATION PROCESS FOR WORLD ASSEMBLY 2023

Do you need a visa to Indonesia?

Prepare the necessary documents to be presented at airport immigration.

VoA is applied for by delegates upon arrival at the airport in Indonesia

Fill in the Passport Information of the Registration form.

Prepare the payment of 500,000 rupiah and the necessary documents to be presented at airport immigration.

NO, I AM NOT ELIGIBLE FOR E-VOA/VOA - I WILL NEED AN E-VISA

An e-Visa is applied for by the Local Host Committee online, as early as 90 days before World Assembly 2023.

1. As early as possible, fill in as much of the Passport and Visa Information sections on the Registration form.
2. Book your flight(s) or get a flight quote in your name.
3. Update any remaining Passport and Visa Information in the Registration Form and upload the required documents.
4. As your sponsor, the Local Host Committee will submit an e-visa application on your behalf.
5. If the application is approved, you will receive an e-Visa by email.
6. Prepare the necessary documents to be presented at the airport immigration.

Uploaded documents need to meet these specifications:

- File format JPG/JPEG
- Size 100-400 KB

Required documents include:

- Passport Cover
- Passport Biodata page
- Return Ticket/Flight Quote
- Full Covid-19 Vaccine certificate(s)
- Travel Insurance/Health Insurance

■ Photo of self with specifications:

(1) Color; (2) Solid white background; (3) Photos taken within the last 6 months; (4) Not the result of editing or image processing

Documents required at airport immigration

Visa Exempted

Mandatory documents:

1. Full Covid-19 vaccine cert(s) (digital/printed).
2. Printed Return ticket/flight itinerary.
3. Passport that is still valid for at least 6 months.

You are also advised to bring along:

1. Invitation letters from Perkantas and IFES.
2. Any other vaccine certificates required based on your country of origin.

Electronic Visa on Arrival (e-VoA)

Mandatory documents:

1. Full Covid-19 vaccine cert(s) (digital/printed).
2. Printed return ticket/flight itinerary.
3. Passport that is still valid for at least 6 months.
4. Electronic Visa on Arrival (printed/digital).

You are also advised to bring along:

1. Invitation letters from Perkantas and IFES.
2. Any other vaccine certificates required based on your country of origin.

Visa on Arrival (VoA)

Mandatory documents:

1. Full Covid-19 vaccine cert(s) (digital/printed).
2. Printed return ticket/flight itinerary.
3. Passport that is still valid for at least 6 months.
4. Cash of at least 500,000 rupiah.
5. Invitation letters from Perkantas and IFES.

You are also advised to bring along:

1. Any other vaccine certificates required based on your country of origin.

E-visa

Mandatory documents:

1. Full Covid-19 vaccine cert(s) (digital/printed).
2. Printed return ticket/flight itinerary.
3. Passport that is still valid for at least 6 months.
4. Printed e-Visa approval letter from Indonesian government.

You are also advised to bring along:

1. Invitation letters from Perkantas and IFES.
2. Printed guarantor letter from Perkantas.
3. Any other vaccine certificates required based on your country of origin.
